The fourth edition of Concrete Ideas was themed 'PPPs in Urban Regeneration: Global Best Practices, Nigerian Opportunities' emphasized that PPPs must include the 4th P which is the People. The People must be at the centre of any regeneration project in Nigeria in order to drive real and impactful change.

The fifth edition – a hybrid event focused on 'Building up Safely: Government – Industry Collaborations', with the Executive Governor of Lagos State, Babajide Sanwolu was the Special Guest of Honour represented by the Deputy Governor of Lagos State, Dr. Obafemi Hamzat. The experts explored how high-rise buildings could be a solution to the problem of scarcity and high-cost of accommodation in urban centres in Nigeria, and how they could be a spur of investment in construction and real estate. From the discussions, recommendations, policy ideas and deep insights shared, it was agreed that 'building up' safely is the best solution to tackling the problem of scarcity and the high cost of accommodation in urban centres in Nigeria.

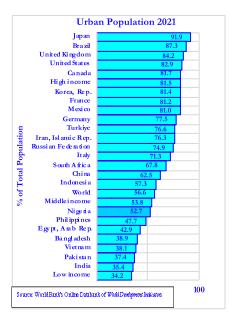


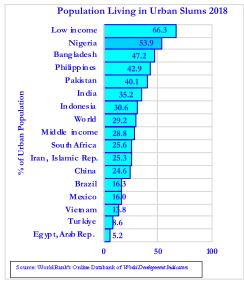


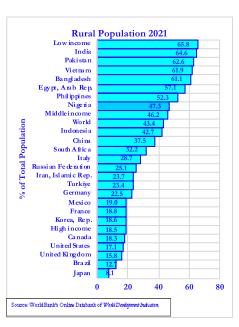
## | Policy Blueprint for Regenerating Nigeria's Real Estate

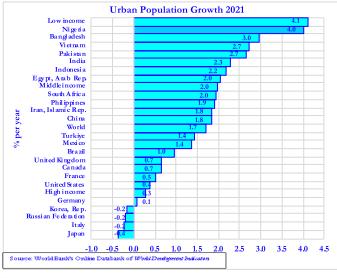
#### 1. REALITIES

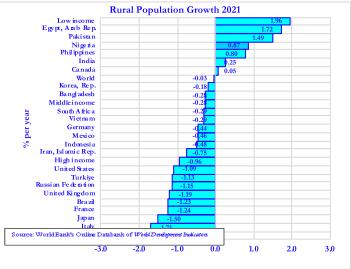
Nigeria had 111.4 million urban dwellers in 2021, a little over half or 52.7 percent of the 211.4 million population. Nigeria's 52.7 percent urban population is close to the 53.8 percent average for middle-income countries and the 56.6 percent average for the world, suggesting the typicality of the Nigerian urban population.

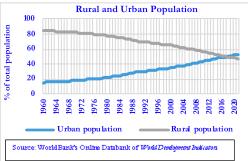


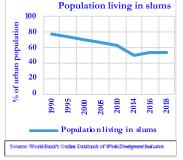


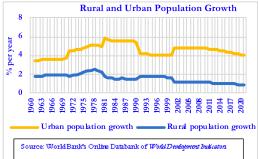
















Only 51.57 million people live in habitable **urban housing**, 46.6 percent of urban 11 dwellers or 24.39 percent of the population; 159.99 million live in inhabitable urban and rural slums as much as 75.61 percent of the Nigerian population are effectively gentrified.

- 60 million people live in inhabitable **urban slums**: 53.4 percent, of urban dwellers or 28.38 of total the population. Nigeria's 53.7 incidence of urban slums is almost twice as large as the 28.8 percent average for middle-income countries or the 29.2 percent average for the world, suggesting the exceptionality of Nigeria's incidence of urban slums. The goal should be to eradicate urban slums, as high-income countries have done.
- 99.99 million live in inhabitable **rural slums**; 47.3 percent of the population. Nigeria's 47.3 percent rural population is close to the 46.2 percent average for middle-income countries and the 43.4 percent average for the world, suggesting the typicality of the Nigerian rural population.<sup>1</sup>

The main takeaways from these stark facts are that 75.6 percent of Nigeria's population are already excluded from the economy and urgently need gainful employment opportunities, infrastructure, and other socio-economic amenities that they cannot get in the urban and rural slums that they are trapped in to be able to afford habitable dwellings.

This fits into a common pattern in developing countries in which people migrate from rural slums (on the fringes of farming, husbandry, fishing, forestry, hunting, and mining that are controlled by landowners in the rural core) to urban centres in search of better livelihoods mostly end up in urban slums (on the fringes of commerce and industry in the urban core), as long as they do not have the literacy, skills, and exceptional talents required for assimilation into the urban core.

'A slum is a residential area with substandard housing that is poorly serviced and/ or overcrowded, and therefore unhealthy, unsafe, and socially undesirable'<sup>2</sup>. 'Rural and urban poverty may have common characteristics- adequate employment, food, health care, and education are issues that are common concerns. So are access to information and lack of voice and representation in the settlements in which they live. In either case, their ability to influence decision-making is remote since they end up *powerless in the face of the landed gentry in villages and the rich and organized classes in cities*'<sup>3</sup>.

Empowering the poor with the *capital*, *literacy*, *and skills* needed to *penetrate rural or urban cores* is the ultimate way to *improve their livelihoods* to the point that they can afford to *move out of slums into habitable homes*.

#### 2. POLICY IDEAL

For high-income countries that have effectively eradicated urban slums and are progressively urbanizing their rural cores Real estate narratives are now focusing single-mindedly on urban regeneration. Low- and middle-income countries that still have high incidences of slums in urban and rural areas must follow the three-pronged approach enunciated below in framing their real estate narratives:

• Slum Eradication<sup>4</sup> is a process by which the vast physical capital and human capital that are lost to slums are put to more productive use for the overall benefit of the society:







- i. *Physical Capital Productivity*: Wealth created in places will be enhanced by small changes that have high payoffs, such as converting economic dark spots to bright spots. cost centers to revenue centers, dirty places to clean places, crime centers to wealth centers, unsafe places to safe places, insane places to sane places, disorganized places to organized places, and replacing unclear protocols with clear protocols. ii. *Human Capital Quality:* Wealth created by people will be enhanced by access to educational opportunities that enable them to unlock the skills and talents needed for productive careers that make them fit for rural and urban cores.
- **Rural Urbanization**<sup>5</sup> described by Ofori-Amoah (2017) as 'A process by which rural areas become urbanized', following two tracks:
- i. Planned Rural Urbanization (PRU) 'derives from direct interventions from government and private interests', and has been implemented through state creation, local government creation, planned cities, garden cities, industrial estates, and growth centers in different parts of Nigeria at different points in time.
- ii. Unplanned Rural Urbanization (URU) 'works through spontaneous and random corporate and individual behaviors that cumulatively transform the rural landscape'. Commercial growth, non-metropolitan industrialization, and sub-urbanization catalyzed by growing networks of road, rail, seaport, and airport infrastructure have occurred in different parts of Nigeria at different points in time.
- **Urban Regeneration**<sup>6</sup> is a process by which aging obsolete stocks of real estate in urban neighbourhoods are periodically renewed and adapted to meet the evolving demands of social, economic, technological, and ecological advancements of Residential spaces, such as the inner cities or down-towns, low-, middle- and high-income neighbourhoods that are aging.
- iii. Commercial spaces like central business districts or city centres, major markets, transit routes, and transit stops are all aging.
- iv. Even the *government's real estate spaces* like secretariats, schools, hospitals, barracks, police stations and prisons are all aging.

Knowing the aggregate sizes of the problems to be solved is only the first step. The second step is to get different states and municipalities to know their share of the incidences of *rurality*, *slums*, and *urban decay* and accept to take responsibility for addressing them. The third step is to equip them with practical tools for designing, planning, coordinating, and implementing large-scale *slum eradication*, *rural urbanization*, and *urban renewal*.

#### 3. UNLOCKING REAL ESTATE

Real Estate is the world's oldest and biggest asset. There is huge wealth to be unlocked from real estate. Real estate accounted for 69 percent of global wealth in 2020. Residential real estate including land was at 46 percent of global wealth, while corporate and government buildings including land contributed 23 percent of global wealth<sup>7</sup>.

While the value added in construction and real estate in Nigeria of N25 trillion in 2021 was 14.2 percent of GDP, no one knows the financial value of the stock of real estate in Nigeria or the relative share of Nigeria's wealth stock, it is not likely to be less than 60 percent. This a vital gap that future sessions of **Concrete Ideas** can fill.

Various segments of real estate however have features of both public and private goods such that access to their benefits is excludable in some cases and non excludable in other cases, just as there is rivalry in consumption in some cases (in which units consumed by one party is no longer available to any other party) and there is no rivalry in consumption in other cases (in which the same unit can be consumed by all parties at the same time).

Consequently, the boundaries between segments of real estate that must be provided by the government as public goods and those segments that must be provided by markets as private goods are not always clear-cut. The need to cover huge gaps that will be left by both *pure public provision and pure private provision justifies public-private partnerships*.

Nigeria's built environment is fragmented into (i.) pieces that are held by the three tiers of government- federal, state, and municipal; and (ii.) pieces that are held by three groups in the private sector- households, businesses, and communities.

These all combine to form an intriguing pyramidal segmentation of Nigeria's built environment as follows:



- i. National/Federal Networks: Transport, Energy, Telecom, Drainage, Military, Security Structures.
- ii. Subnational Holdings: Intra-State and Intracity Transport Routes, Transit Stops.
- iii. Municipal Holdings: City Centers or CBDs, Inner-Cities or Downtowns.
- b. Private Sector
- i. Residential Dwellings.
- ii. Commercial/Industrial Structures.
- iii. Communities.

Sectoral specificities often arise along the lines of real estate that are needed for residential. Commercial, Industrial, governmental purposes, or real estate needed for transportation, energy, waste and water, education, health, safety, and security infrastructure. But interlocking needs a narrow focus on individual components like housing, employment, retail, infrastructure, and other issues will not work as any should be considered in isolation from the others.







The solution housing may be new infrastructure, new economic activities, or new employment opportunities, just as inadequate housing may impede the growth of the community, economy, infrastructure, and employment.

Common vision and concerted action by the following heterogeneous actors and stakeholders are needed for progress:

- c. Government as Originator, Planner, and Regulator: Federal, State, and Municipal Government.
- d. Businesses as Agents with the resources to conduct the missions: Builders. Financiers, Managers.
- e. Society/People as End Users and Beneficiaries: Households, Businesses, and Communities.

Top-down government initiatives require vertical *integration* across levels of government, and bottom-up community initiatives require horizontal integration across departments within each community, and across communities to ensure a balance between 'hard' (physical) and 'soft' (social) investment through the conception, planning, execution, and utilization stages in the life cycle of real estate, and across the



conception, design, and *ownership (upstream)*, Finance/Construction *(midstream)*, transactions, usage, maintenance *(downstream) stages in the value chain.* 

#### 4. ATTRACTIONS OF PUBLIC-PRIVATE PARTNERSHIPS

- a. Keeps All Financing Options on the Table.
- Government Financed: Taxation/Debt.
- *Market Financed: Equity:* greenfield, brownfield, long-term project financing (BOT, BOOT, BOO, etc.).
- User Financed: User fees, tolls, and value capture.

- Externalities: Private Returns are not equal to Social Returns.
- *Spillovers*: Limited Direct Benefits in the Presence of Significant Indirect Benefits.

- Identify the Universe of Fundable Projects.
- Streamline Deal Origination Protocols that Public/Private Project Promoters Can Cue into.
- Streamline Deal Consummation Protocols that Local/Foreign Financiers/ Investors/Donors Can Cue into Tiers of government should provide the vision, spearhead the consultative deliberations,

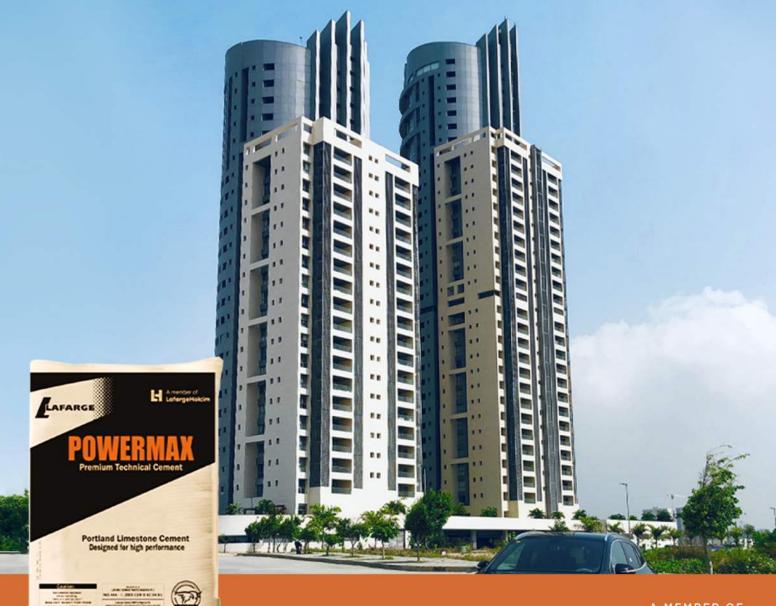
delineate the boundaries, streamline the rules, coordinate stakeholders, ensure transparency, mitigate risks, capture benefits, redistribute benefits while selecting private partners to supply funding, execute the projects, and manage the facilities.

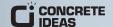

#### 5. VALUE ARCHITECTURE

- a. *Value Metrics:* use values must be equal to or higher than *market values*, or we must take collective steps to close negative value gaps.
- b. *Value Propositions:* Conversations about *slum eradication, rural urbanization,* and *urban renewal* must always be in terms of unlocking latent *benefits or wealth,* and never in terms of incurring costs, or financing. *Real estate portfolios* of each of the three tiers of government include:
- Idle land in prime locations that we can develop for lease/rental income generation
- Uneconomic-built structures on prime locations we can redevelop to unlock rental income.
- Aging and abandoned barracks and stadium complexes around the country can also be re-purposed.
- Major markets, transit stops and tourist locations can be renewed to unlock more wealth from them.

Wherever there are significant gains to be made, it makes sense to go after them. We must only incur costs to unlock benefits. These will be one of the biggest potential sources of government revenue if the various arms of government could allow developers to buy redevelopment rights on their real estate portfolios. Hong Kong funds all its capital budget from this source, while India and China fund significant fractions of their annual budgets from this. We must start by showing the benefits we can unlock by renewing the real-estate portfolio of the federal, state, and local government tiers of the public sector and the commercial and industrial segments of the private sector. We must show the sizes of the benefits that we can unlock. When properly conceived, real estate renewal will fund the government, rather than be funded by the government. The ultimate question is about how to organize government-private actions to unlock, capture, and redistribute funds hidden in real estate.

- c. Value Creation/Capture: Processes, Modalities, and Selection of Partners.
- d. **Value Redistribution:** As there would be gainers and there would also be losers, it is important to be explicit about who the gainers might be and how much they would gain, who the losers might be and how much they will lose, and what arrangements must be put in place to ensure that some of the gains are transferred to the losers to compensate for their losses. This will give slum eradication human face.



#### 6. COMMUNITY TRUST AND BUY-IN8

Where to start is in recognition of the diversity of and the specialness of individual slum communities and to tailor projects to the needs and assets inherent in each community. That way, we can ensure that build community trust in the process. The private sector becomes more of a social entrepreneur than a profit-seeking entity, that can prioritize the social benefits of that project over the maximization of financial returns and factor in the acceptance of that project over time.

There are diverse types of slums. We have the *waterfront slums*, we have the *public housing slums* that we developed, *high-rise*, *four floors*, and all that, *abandoned government estates* that are now *in states of disrepair*. The fundamental question is so, how to choose between slums that were slums from the beginning nd those that were nice housing for low-to-middle-income earners from the beginning but are *now slums* that no one wants to dwell in.

Co-production is about ensuring that slum eradication projects, no matter what their scale is, evolve with inputs from the dwellers it is meant to serve, recognizing them both as end-users as well as partners in that project. They must be at the drawing board when we make decisions on the type of slum eradication project that will suit that area. One of the ways we do this is by asset mapping. Instead of just doing needs analysis, which tells you what the needs of the community are, we also map the assets that people in these communities own, their skills, their trades, their aspirations, as well as the current avenues that they have for improving themselves and their communities. We factor these into the plan so that we can recognize workable solutions from the onset. It enables us to position the people as ultimate beneficiaries or end users.

If you are developing a new product as a commercial enterprise, you want to know who the customers are from the onset, you want to do a market analysis of what they can afford, and you want to know the market segments for that new commercial product. The same way thing should apply to slum eradication projects. We assess the types of empowerment the people need in the short, medium, and long term and what they can also bring into the project. So, in this way, we can develop a product that will work for them sustainably.

Successful slum eradication depends in part on the acceptability of the idea of eradication to the communities. They could be distrustful of private investment because of the pervasive occurrence of gentrification and suspicion that once these projects are completed, they would not be part of it as they would have been outpriced. They could also distrust the governments because trust in the social contract has been undermined by a history of forceful evictions. We must therefore begin by making them buy into the whole idea of slum eradication, however nice they are or however impactful they could be.

Let us co-produce public-private partnership projects as far as we want them.

If you want them to work for slum eradication, let us not forget the people in the mix. And they should be at the table from the start not at the end.

In this way, slum eradication projects can be inclusive.

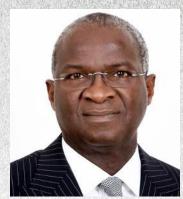

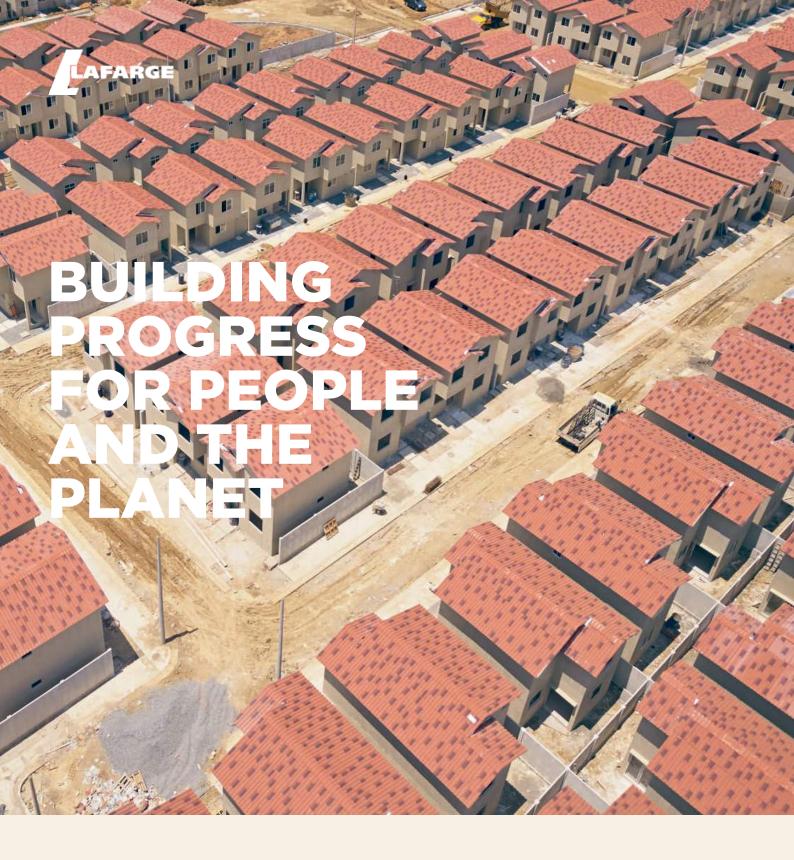
